Albia City Council Regular Meeting Monday, April 15, 2024 Minutes

Mayor called the regular meeting to order at 6:20 p.m. with all council present: Trudy McDowell, Merle Regenold, Scott Kelly, Kathy Mobley, Don Benson & Chris Yarkosky. Supervisors present, Scott Reed-Street Commissioner & Jacob Miller-Chief of Police.

Mayor called for a motion to open public hearing for 2024/2025 public hearing, Regenold moved and Kelly seconded to open public hearing. Motion caried 6-0. No written or oral objections were received. Kelly moved and Regenold seconded to close public hearing and carried 6-0.

Council stated that more ways will have to be found to save money for future budgeting. Kelly moved and McDowell seconded to resolution to adopt 2024/2025 fiscal year budget. Motion failed with Mobley, Benson, Regenold & Yarkosky voting no and Kelly voting yes.

Mobley moved and Regenold seconded to approve consent agenda and carried 6-0.

Nancy Buss, Hall Engineering updated council on monthly construction reports, no written reports were available for council to review, motion to table action on the reports was made by Yarkosky and seconded by Benson and carried 6-0.

Buss also updated the Council on North Plant contract extension for completion. North & West plants will be completed at approximately the same time in September 2024. Next meeting will be a change order to the completion date. UV equipment also needs to be delivered to the North Plant so easements for use of the road are needed.

Ordinance establishing regulations for a pollinator garden was discussed. Kelly felt a permit should be issued; Yarkosky felt issuing a permit would cause unneeded work. After consideration, Kelly moved and Yarkosky seconded to approve 1st reading of ordinance 912 amending Chapter 52 to add language for pollinator gardens as presented. Motion carried 6-0.

Tyler Boley, Chair of RAGBRAI committee, request that Council allow the committee to seed the hotel lot. Black dirt would be brought in to cover clay. All would be done at no expenses to the City. Committee felt this would be a good spot for bikers to rest. After discussion, Mobley moved and Benson seconded to approve the seeding. Motion carried 4-2 with Regenold and Kelly voting no.

Boley also presented an ordinance for the city to consider for the RAGBRAI day. The ordinance would regulate vendors and fees. After discussion, Mobley moved and Yarkosky seconded to approve the form of ordinance for RAGBRAI and carried 4-2 with Regenold & McDowell voting no. Will be placed on next agenda for readings.

Mayor discussed with council trees along the right-o-way needing replaced, this is near HyVee, and funds are available from Francis Cooper funds for this. After discussion, Yarkosky moved and Benson seconded to table action to a future meeting for more information, and carried 6-0.

Chief discussed giving business owners an incentive to fix their alarm systems, several alarms are going off without cause. Police have to respond to the alarms then being a false alarm. Chief suggested imposing fines after a set number of false calls. Will be placed on next agenda.

Yarkosky moved and Mobley seconded to approve 1st reading of ordinance 913 amending Chapter 85, Section I (85.18). Motion carried 6-0.

Mobley & Chief presented the job description for a Community Service Officer position. After consideration a motion was made by Regenold and seconded by Mobley to approve description and advertise for the position, motion carried 6-0.

Chief informed Council that an officer has submitted a resignation. Requested to advertise and hire an officer. After discussion, Benson moved and Yarkosky seconded to advertise & hire for a police officer. Motion carried 5-1 with Regenold voting no.

Main Street Report-Tyler Boley represented Albia Chamber Main Street and asked if the council would complete and request other to complete the community survey. Also shared the route for intown RAGBRAI and plans for the day and business this day will bring to the community.

Mobley moved and Benson seconded to approve sending alley closing request to Planning & Zoning for recommendation and carried 6-0.

Supervisors Reports-Street Commissioner-Wayfinding Signs are installed. Has done some more research on the brush dump grinding all chippers quotes are higher than from Chamness. Parttime mower started April 15, 24 & transformer has failed in the shop welder and will be looking for new as parts are not available for the old one.

Chief of Police-Officer will graduate at the end of April.

Council Comments: McDowell-inquired about the dog park and opening. Regenold- cautioned on donating money and setting requirements. Mobley-light is out on flag pole at the Library. Benson-inquired about construction for new day care.
